Property owners have opportunity to submit Section 78 queries to be considered. A Section 78 query is a submission made to the municipality that a property has been incorrectly valued, coupled with a request that the municipality re-consider the valuation of such property.

GARA met with the Ward Inspector for Ward 92 and pointed out various issues in Glen Austin that GARA believes do not conform to the City of Johannesburg Land Use Scheme. She undertook to follow-up on the issues and provide feedback to GARA.

The Ward Inspector suggested that residents log any issues with the relevant City of Johannesburg

department listed below. It is crucial to obtain a reference number and date for every issue reported. ### Spatial Frameworks, the Spatial Development Framework and SPLUMA

The City of Johannesburg has a clear and well informed spatial vision, expressed through its Spatial Development Framework. This policy is given significant legislative backing through the Spatial Planning and Land Use Management Act 16 of 2013 (SPLUMA). SPLUMA indicates that no land use decision may be made that is not in line with the SDF, unless there are good site specific reasons.

This document (linked below) sets out the procedure and requirements for the formulation of Spatial Frameworks (SF's) in the City of Johannesburg (CoJ). While Spatial Frameworks are generally prepared by the City of Johannesburg, there are occasions where an external party believes a Spatial Framework for a certain area is needed, and the City is not in a position at that time to prepare such a plan (due to budget constraints as an example).

Glen Austin outreach programme
What is the Glen Austin Outreach
programme you ask? Well, it's a group
of Glen Austin volunteers who give their
time every 2nd Wednesday to collect
produce from the community and
distribute these items to individuals and
families who need the support. Fruit,
vegetables, eggs, Kombucha, sometimes
homemade soup, dry goods and similar,
are examples of what is being donated –
locally grown and organic, where
possible.

At present we have about 29 people on our list who benefit from this scheme.



Any items remaining at the end of the deliveries are donated to a local Pastor, who has a feeding scheme for street people.

About two years ago, at the start of COVID, Judy Bird put forward this idea to a few community friends, as she felt, and knew of a lot of people who were struggling because of the tough economic times. And so, the GA Outreach Programme took flight.

We approached people in the area, including some businesses, who were only too happy to help contribute their excess vegetables. These companies and individuals are still assisting us today and we would like to raise a toast to all these guys and in particular to Rudolf of Eat You Greens in Pitzer Road, and June Law of June's Farm Produce in Milner Road.

The team are always looking for extra produce/food/canned items and also team members who would be willing to give up a few hours every 2<sup>nd</sup> Wednesday. Remember by sharing your produce or time you will contribute to a vital community role and fill some hungry stomachs for a good few days.

Who is the Midrand SPCA and function do they fulfil in Midrand?

The Midrand SPCA is the Society for the Prevention of Cruelty to Animals While the Midrand SPCA does not take away from the good work that other welfare organisations may do, many people are still under the impression that we are only there for the cats and dogs. This is a far cry from the truth as we are the Society for the Prevention of Cruelty to ALL Animals.

The Midrand SPCA was established in 1991 as there was a great need for assistance especially taking into consideration the rapid development of Midrand and the influx of animals into residential areas, Informal settlements and impoverished communities.



We investigate all cruelty complaints, inspect pet shops and exhibits, take in all stray, abandoned and unwanted animals and we have a small clinic that focuses on providing Basic health care for pet owners who cannot afford private veterinary care.

We further inspect Abattoirs, Hawking sites, Coal yards, Security companies, correctional facilities, Cull outlets, Zoos, and many other facilities where animals are housed to ensure that all animals are treated in a respectful and humane manner irrespective of what their end destination may be.

The SPCA movement works on prevention of cruelty to all animals – we investigate dog fighting, rodeos, pigeon racing and any other events where animals are used for sporting purposes.

The Midrand SPCA does not receive any Government Funding and therefore rely solely on the public for donations of food and monetary value.

The Midrand SPCA covers a vast area of approximately 160 square kilometres: including Country View, Blue Hills, Carlswald, Crowthorne, Glen Austin, Halfway house, Vorna Valley, Rabie Ridge, Randjesfontein, Glenferness, Kyalami, Riversands, President Park, Midstream and parts of Tembisa.

#### **Inspectorate Department**

In the past financial year, our team of 3 inspectors collected over 1000 unwanted animals, attended to 91 by-law related complaints, issued 389 warnings in terms of the Animal Protection Act, conducted 174 pro-active inspections, 247 follow-up inspections and investigated 285 cruelty complaints. We currently have 3 court cases pending, attended to 284 after-hour complaints and took on 269 other collections.

During their pro-active inspections, they inspected over 11 000 animals and over 4000 animals were involved in their cruelty investigations. We have also rescued over 33 animals that were rescued from trees, highways and other situations that placed the animals' lives in danger. 200 pre- and post home inspections were also conducted to ensure that the animals we home out or have been homed out, are given the best second chance at a good life!

#### **Environmental News**

#### How to care for your Septic Tank

A septic tank is a living filter that separates scum and solids, and pretreats wastewater before it flows out into the drain-field for final purification. It takes 24 to 48 hours for this process. Even a good system not cared for may become a neighbourhood health hazard and an expensive problem. Failed systems may cause ground and surface water pollution and costly property damage. It is important to maintain your septic system.

#### Don't put these into your system:

- Fats or grease
- Motor oils or fuels
- Disposable diapers
- Coffee grounds, egg shells, nut shells
- Filter tip cigarettes
- Sanitary napkins, tampons or condoms
- Paper towels or rags (flushable wipes)
- Dental floss
- Cat litter
- Paints or chemicals

These materials kill the bacteria, won't decompose and will fill the septic tank and will plug the system.

#### Don't poison your septic tank

Drain cleaners, floor cleaners, toilet bowl cleaners, paints solvents, waxes, polishes, coating or strippers may destroy important bacteria in the septic tank and contaminate ground and surface water. Avoid any product that targets the killing of germs, as germs is what is keeping your septic tank operational.

Rather buy products specifically marked as safe for septic tanks or use diluted white vinegar and bicarb of soda (baking soda) as cleaning agents.

Various cleaning products homeowners use can harm the good bacteria in a septic system. Avoid using chemicals like bleach around the house. Rather use bio-degradable products like "Yemvelo", which can be bought from Takealot.

## How Do I Clean the Toilet Bowl With a Septic System?

It's best to stick with natural products that won't kill the vital, waste-eating microorganisms that live in your septic tank. Check the labels on cleaning products for a septic-safe label, or use a home-made mix of vinegar and bicarb powder. (See above for link to instructions.) While it might be tempting to resort to the products that are advertised to kill 99.9 percent of all germs, these products can harm your septic system by killing the helpful bacteria. Non-chemical cleaning products are better for the environment, which includes the drain field of your septic tank.

#### How does a septic tank work?

Septic tanks usually have 2 chambers (3 chambers are better). The waste is flushed into the first one where the anaerobic process (driven by good bacteria) starts digesting the waste. As the tank fills up an overflow system allows mainly fluids, solids in suspension and some of the smaller particles of waste to overflow into the second chamber. Here the anaerobic process

continues to digest the waste into water and gas. The intention of this design is that the overflow from here into the soak-away or French drain should only be clear fluids. This water then seeps away into the ground through this drain.

#### How to look after your septic tank

Adding specific bacteria, like found in "Bio-Activator" will speed up the anaerobic process in both chambers of the septic tank so that the waste is efficiently digested into water and gas. The results of this process will then flow into the soak-away/French drain and also clear the blockage here so that the water can seep away freely. Unless the septic tank or soak-away/French drain has physically collapsed there is no need to build a new one or to have it pumped out ever again.

#### What is Bio-Activator?

#### **Benefits for toilets**

The lifespan of septic tanks can be extended almost indefinitely depending on the amount of rubbish such as plastic packets, nappies, sanitary towels, etc. already in the pit/trench and also as long as no more is thrown in.

The regular (quarterly) use of this product will prevent the level of the waste from rising and the pit/trench will not get full. It should therefore not be necessary to dig another pit again while it is being treated with Bio-Activator and if no more rubbish is thrown into the toilet.

There should never be any reason for a septic tank to be emptied with a vacuum tanker if correctly treated. Regular treatments with Bio-Activator and good housekeeping practices can make this a reality.

Sector 1 covers the area from Allandale Road in the South, N1 South from Allandale to Corporate Park North, Randjesfontein, Glen Austin, President Park, Halfway House Central, plus all businesses within this boundary.

We have one of the busiest sectors in relation to crime, especially business robberies, due to the large no of companies in the sector, Assault GBH and common robbery of pedestrians, these are mostly recorded in Halfway House Central, though they do occur in number in Glen Austin and President Park but are generally not reported nor cases opened.

We would like to encourage all residents to get onto the social platforms, especially the Emergency group. This group is aimed at reporting only IMMEDIATE emergencies, please don't spam it with non-relevant messages.



Street groups are there to receive and give information. Please report all incidents, fence cutting, theft, suspicious vehicles, people. All this information is used and reported to Saps and for planning patrols.

When reporting vehicles and people, we need as much detail as possible and registrations of vehicles, direction of travel etc.

City warns property owners over the annual increases on municipal bills.

The City has warned property owners will receive higher-than-normal municipal bills for July 2023.

Increases in ratepayers' monthly bills results from the implementation of the annual tariffs on municipal service charges, property rates, effected by new property values which are aligned to the General Valuation Roll (GVR) 2023, and the lapsing of pensioner rebates.

All pensioners who received property rebates that lapsed on 30 June 2023 need to reapply and be re-evaluated to qualify for the new rebates. The City is sensitive to the needs of senior citizens, and all municipal accounts of registered pensioners who were previously approved to receive the lapsed pensioner rebates will immediately be flagged from any possible credit control action until the end of September 2023.
