Application for Pensioner Rebate on Property Rates

Please attach the following certified documents: Copy of Identity Document, Proof of Monthly Income AND previous income tax year final assessment from SARS.

It is important to note that only a signed form together with all the relevant documentation (as mentioned in the sections below) will be accepted for further processing. Failure to provide the required documentation will result in the application not being approved. If your financial position changes please let us know.

CONDITIONS

Pensioners must be 60 years of age or older, own property and personally occupy the property. The property value must not exceed R2 500 000

Pensioners dependent on a National Security Grant qualify for 100% rebate on successful applications.

Pensioners who are not on National Security Grant, but whose gross monthly income falls below R9 244 qualify for 100% rebate on successful application.

Pensioners who are not on National Security Grant, but whose gross monthly income is above R9 244 but less than R15 846 qualify for 50% rebate on successful application.

In case of dual ownership, at least one of the owners must be 60 years of age or older.

The rebate is applicable for only one property should the applicant own more than one property.
