	5(1)	Erect a sign painted on the roof of a building or painted on, attached to, or fixed between the columns or post of a veranda.	R500
	5(2)(a)	Erect a sign to project above or below fascia, bearer, beam or balustrade of a street veranda or balcony.	R500
	5(2)(b)	Erect luminous or illuminated sign which is fixed to a fascia, bearer, beam or balustrade or splayed or rounded corner of a street veranda or balcony.	R500
	5(3)	Erect a sign to be suspended across a street.	R1000
	5(4)	Erect a sign on calico, paper mache, plastic, woven or similar material or of any kind whatsoever	R1000
	5(5)	Erect a swinging sign, which is not rigidly and permanently fixed.	R500
	5(6)	Erect or cause a sign which may either obscure a road traffic sign, be mistaken for, or interfere with the functioning of a road traffic sign.	R500
	5(7)	Erect a sign which may obscure traffic by restricting motorists vision and lines of sight, thus endangering motorists' safety.	R1000
	5(8)	Erect a sign which is indecent or suggestive of indecency, prejudicial to public morals or is reasonably objectionable.	R1000
	5(9)	Erect a sign which obstructs a window, or opening provided for the ventilation of a building or which obstructs a stairway, doorway, or other means of exit from a building or which will prevent the movement of persons from one part of a roof to another part thereof.	R1000

	5(10)	Erect an animated or flashing sign, the frequency of the animations or flashes or other intermittent alternations of which disturbs the residents or occupants of any building or is a source of nuisance to the public, or impairs road traffic safety.	R1000
	5(11)	Erect an illuminated sign, the level of illumination of which unreasonably disturbs the residents or occupants of any buildings, or is a source of nuisance to the public.	R1000
	5(12)	Erect a movable temporary, or permanent sign, other than those specifically provided for in these By-laws.	R1000
	5(13)	Erect a sign referring to a price, or change in price, or merchandise except in a shop window, or on the article.	R1000
	5(14)	Erect an advertisement or sign other than an exempted sign, for which neither a permit nor approval has been obtained.	R1000
	5(15)	Erect a poster otherwise than on a hoarding legally erected for the purpose of accommodating such poster.	R100 per poster
	5(16)	Erect a sign, the total area of which exceeds 30m², painted or fixed on a wall of a building not being a front wall of such building, unless approved in terms of the policy for the promotion of Outdoor Advertising in the Johannesburg Inner City.	R500
	5(17)	Erect a sign painted on a fence or boundary wall, not being an approved sign or hoarding.	R500
	5(18)	Erect a sign which does not comply with the requirements of or which is not permitted by these By-laws.	R1000

	5(19)	Erect a sign which is causing an obstruction to pedestrians or vehicular traffic.	R1000
	5(20)	Erect a form of a flyposter a on private or Council property or assets.	R500
	5(21)	Erect a transit advertising sign that is parked irrespective of whether it is attached to a vehicle or not.	R1500
	5(22)	Erect a poster or sign attached to a tree.	R100 per poster
	5(23)	Erect a poster attached or pasted to a bridge.	R100 per poster
	5(24)	Erect a temporary sign for commercial or third – party advertising erected on Council land or land vested in the Council, unless by prior signed encroachment agreement or contract with the Council.	R1000
	5(25)	Erect a sign attached to a bridge or any other Council asset.	R1000 per sign
	5(26)	Erect a third party advertising sign on a property zoned “Residential” in terms of the relevant Town Planning Scheme whether secondary rights or not have been granted by Council and which are exercised on the Erf.	R1500
	5(27)	Erect a sign or poster attached to a road traffic sign.	R100 per poster
